Polk County has an estimated 42,600 residents and is part of a four-county area served by Floyd Polk Medical Center, a 25-bed critical access hospital with emergency medicine, surgery and diagnostic imaging capabilities, Floyd Medical Center, a 304-bed acute care safety net hospital, and a third, HCA-owned hospital.

The land area of Polk County covers 310.34 square miles, and the population density is 133.6 people per square mile. Eighty-three percent (83%) of Polk County students are eligible for the federal free lunch program. Seventy-nine percent (79%) of Polk County residents have a high school diploma or general education development (GED) certificate, and twelve percent (12%) have a bachelor's degree or higher.

Athletic trainers to schools cost the organization \$1,328,796 in the past fiscal year.

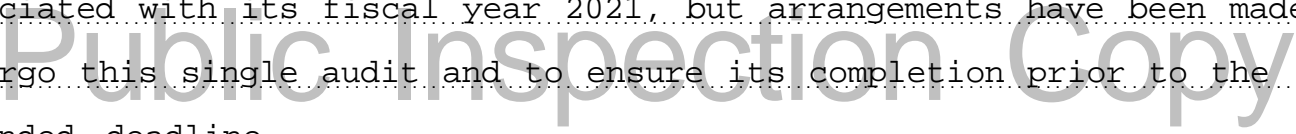
